Equality Act 2010 Durham Gilesgate Primary Schools' provision of the public sector equality duty

Date: March 2018

We in Durham Gilesgate Primary School are committed to equality. We aim for every pupil to fulfil their potential no matter what his/her background or personal circumstances.

We maintain the aim of embedding principles of fairness and equality across our entire curriculum, in assemblies and acts of collective worship, in break and lunchtimes, in pastoral support and in before and after school activities.

We must under the general duty of public sector equality duty, in the exercise of our functions, have due regard to the need to:

- ✓ Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited under the Act.
- ✓ Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- ✓ Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

This will apply to all pupils, staff and others using the facilities. We will give relevant and proportionate consideration to the public sector equality duty.

The protected characteristics for the schools provisions are:

- Disability
- Gender reassignment
- Pregnancy and maternity
- Race
- Religion or belief
- Sex
- Sexual orientation
- Age (only applicable to staff, not pupils)
- Marriage and Civil Partnerships (only applicable to staff, not pupils)

Age and marriage and civil partnership are NOT protected characteristics for the schools provisions for pupils.

We will have **due regard** to advancing equality of opportunity including making serious consideration of the need to

- remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
- take steps to meet the needs of persons who share a protected characteristics that are different from the needs of persons who do not share it;
- encourage persons who share a relevant protected characteristic to participate in public life or in any activity in which participation by such persons is disproportionately low.

We will take into account the six Brown principles of 'due regard'

- **awareness** – all staff know and understand what the law requires
- **timeliness** – implications considered before they are implemented
- **rigour** – open-minded and rigorous analysis, including parent/pupil voice
- **non-delegation** – the public sector equality duty cannot be delegated
- **continuous** – ongoing all academic year
- **record-keeping** – keep notes and records of decisions & meetings

We welcome the opportunity to be transparent and accountable. To this end we fulfil the specific duties of the Act by:

- ✓ publishing our equality information
- ✓ publishing our equality objectives

We aim to make the information accessible, easy to read and easy to find.

Equality Information:

We maintain confidentiality and work to data protection principles. We publish information in a way so that **no pupil or staff member** can be identified.

As we are only required to complete a staff profile if we have 150 or more members of staff this information has not been provided in order to ensure that no individual can be identified.

Equality Objective 1:- Professional Development

<i>To ensure that all staff (including mid-day supervisors, cleaners etc) are trained in the Equalities Duty and the implications for school. Governors will be invited to this training</i>

Action	Success Criteria
<p>Update Professional Development for all staff so that they fully understand the school policy and expectations around equality.</p> <p>Ensure that all staff have and know how to use the reporting system for prejudice related bullying.</p> <p>Monitor to make sure that systems are impacting well on the priorities we have identified.</p>	<p>Staff will be aware of the Equalities Duty and the impact that this has on them.</p> <p>All equalities related incidents will be reported in line with the school system.</p> <p>CPD in January 2017 ensured compliance but refresher training is required to ensure that staff are kept up to date with developments.</p>

Equality Objective 2:- Disability (SEND)

<i>To ensure that disabled children are as equally able to attend sporting events, festivals or tournaments as are the non- disabled children.</i>	
Action	Success Criteria
<p>To plan and schedule sporting events, tournaments, and festivals so that equal opportunities exist for disabled children.</p> <p>To plan through our OPAL grounds development opportunities so that disabled children can access all new grounds developments.</p>	<p>Tracking of attendance at such events will show that children with disabilities are able to attend and participate in sporting events.</p> <p>(We have achieved this by July 2016 and monitoring will show that provision is consistent year on year.)</p> <p>New in 2017-2018 disabled children will be able to access planned playground developments alongside non-disabled children.</p>
<i>To ensure that children with SEN make good progress throughout the school from their respective starting points</i>	
Action	Success Criteria

Tracking and use of assessment data will inform Pupil Progress meetings where SEN progress is discussed.	SEN pupils will start to make improved progress by July 2017.
Teachers will be trained in completing referral forms for outside agencies to ensure swift referral.	This objective is ongoing throughout 2017-2018.
Teachers will be given time to update provision maps and SEN support plans.	

Equality Objective 3:- Race

To ensure that those children with English as an additional language make good progress from their respective starting points.	
Action	Success Criteria
To ensure that ongoing work with the Local Authority service for EAL pupils is ongoing.	That EAL children will make good progress from their respective starting points.
To train an existing teacher and member of support staff in order to build capacity to support children who are new to English.	That those who are new to English will make quick progress in learning English.

Equality Objective 4:- Religion or belief

To ensure that all children, regardless of their religion or belief , are able to develop an understanding of World Religions and the similarities between religions.	
To ensure that all children have the opportunity to reflect and develop their understanding of spirituality.	
Action	Success Criteria
Ensure that the SACRE curriculum is taught in full and that there is an appropriate balance between the World Religions.	Monitoring will show that there is a balance of teaching from all World Religions.
Ensure that there are opportunities to visit places of worship from non-Christian religions.	There will be planned opportunities to visit non-Christian places of worship.
Maintain opportunities for a shared prayer space for use by all children.	The school will maintain its shared prayer space work.
Develop links so that faith members from World Religions are invited into school	That faith members from at least 2 World religions will visit school to work with children.

Equality Objective 5:- Sex (Gender)

To ensure that the achievement of boys in English improves and that the difference between boys and girls diminishes	
Action	Success Criteria

Tracking and use of assessment data will inform Pupil Progress meetings where gender progress is discussed.	Boys will make improved progress and difference between attainment for boys and girls will start to be diminished by July 2018.
Quality first teaching to ensure that boys are motivated to read and write.	
The use of targeted intervention, where and if needed.	

Equality Objective 6:- Disadvantage

To ensure that the achievement of disadvantaged children increases so that the gap between the attainment of the disadvantaged group and non-disadvantaged group diminishes.	
Action	Success Criteria
Tracking and use of assessment data will inform Pupil Progress meetings where disadvantaged progress is discussed.	Disadvantaged children will make improved progress and the difference between attainment between the disadvantaged and non-disadvantaged group will start to be more evenly distributed through the school by July 2018.
Quality first teaching to ensure that underachieving disadvantaged children are a focus group in lessons.	
The use of targeted intervention, where and if needed.	

We will update our equality objectives every four years and will publish progress on them annually (These objectives were reviewed in March 2018)

We adopt a whole school approach to equality and consider it important for pupils to learn about equality and human rights. We adhere to the Equality and Human Rights Commission (EHCR) statement:

'To reap the full benefits of equality and human rights education, it is essential to teach topics in an environment which respects the rights and differences of both students and teachers. Without an equality and human rights culture within the classroom and school as a whole, learning about these topics can at best appear irrelevant, and at worst, hypocritical. The respect and tolerance it teaches will help staff and students create a healthier, happier, fairer school culture, and could lead to reductions in bullying and other negative behaviour, and improvements in attainment and aspirations.'

Though the Act refers to 'race', the use of ethnic/ cultural origin, background or heritage is often more appropriate
